B. Warrants

Approved the Warrant Register of December 1, 2008, in the amount of \$70,262.84.

C. Establish the Assistant City Manager position as a budgeted position within the City's Fiscal Year 2008-09 Operating Budget

This was a request for authorization to establish the Assistant City Manager position as a budgeted (funded) position, and unfund the Administrative Services Director position. Both positions exist within the Los Alamitos Executive Management Schedule.

The City Council approved the funding of the Assistant City Manager position and unfund the Administrative Services Director position within the Fiscal Year 2008-09 Operating Budget.

D. Award of Professional Services Agreement for Construction Management and Inspection Services for the Carrier Row Street Rehabilitation Project (CIP 08/09-02)

This report recommended provision of construction management and inspection services that would facilitate the construction of the Carrier Row Street Rehabilitation Project.

The City Council authorized the Interim City Manager to approve a Professional Services Agreement with CBM Inc. in the amount of \$57,995 for Construction Management and Inspection Services.

A. Certification of November 4, 2008 Election Results

This report related to the certified statement of the vote from the Orange County Registrar of Voters, for the General Municipal Election.

City Clerk Vanderpool summarized the staff report.

Council Member Driscoll stated her intent to vote "No" because she thought the winners of the election should have denounced the smear campaign against her and Mayor Parker, and they had not.

Carried 4-1 (Driscoll cast the dissenting vote): The City Council adopted Resolution No. 2008-41, entitled "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LOS ALAMITOS, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 4, 2008, DECLARING THE RESULTS, AND SUCH OTHER MATTERS AS PROVIDED BY LAW".

10. CITY COUNCIL REORGANIZATION

This report provided relevant information for the City Council's annual reorganization, by the election of Mayor and Mayor Pro Tem. The City's Charter requires that roll call votes be taken for the election of these two Officers.

City Clerk Vanderpool opened the nominations for Mayor. Council Member Stephens nominated Council Member Grose, seconded by Council Member Poe.



Council Member Edgar expressed excitement with the new Council, stating it was time to come together as a more cohesive body. He thanked all that voted, and welcomed the new Council Members.


11. ADJOURNMENT
