

1 **NOW THEREFORE**, it is mutually understood and agreed by AUTHORITY and CITY that
2 Agreement No. C-8-0192 is hereby amended in the following particulars only:

3 1. Amend **ARTICLE 8. TERM OF AGREEMENT**, Page 4 of 6, as last changed by
4 Amendment No. 13, to delete in its entirety and in lieu thereof insert the following:

5 “This Agreement shall commence July 1, 1998, and shall continue in full force and effect
6 through June 30, 2010, unless earlier terminated or extended as provided in this Agreement.”

7 2. Amend **ARTICLE 9. PAYMENT**, Page 4 of 6, as last changed by Amendment No. 13,
8 to delete paragraph A in its entirety and in lieu thereof insert the following:

9 “A. For services provided by AUTHORITY for the period July 1, 2009
10 through June 30, 2010, CITY shall pay AUTHORITY the amount of Nine
11 Dollars and Thirty-One Cents (\$9.31) per Vehicle Service Hour at an
12 amount not-to-exceed Three Thousand, Four Hundred Ninety-One
13 Dollars and Twenty-Five Cents (\$3,491.25).”

14 3. Amend **Exhibit A "Scope of Work"**, as last changed by Amendment No. 13, to delete
15 paragraph 11 in its entirety and in lieu thereof insert the following:

16 “11. The CITY has budgeted \$3,491.25 for the period July 1, 2009 through
17 June 30, 2010. The service provided to the center(s) shall not exceed
18 this amount. The estimated number of trips for all centers from July 1,
19 2009 through June 30, 2010 is 1,659. The AUTHORITY does not
20 guarantee that all budgeted trips will be provided.”
