

**RESOLUTION NO. 2009-10**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
LOS ALAMITOS ADOPTING A SCHEDULE OF PENALTIES  
FOR MUNICIPAL PARKING VIOLATIONS.**

**WHEREAS**, California Vehicle Code Section 40200 authorizes cities to impose and collect civil fines and penalties for violations of any regulation pertaining to the standing or parking of a vehicle, as specified in the California Vehicle Code provided such violations are not misdemeanors; and,

**WHEREAS**, the City of Los Alamitos is authorized to establish and impose penalties for violations of municipal parking violations; and,

**WHEREAS**, the Police Department issues citations for parking violations pertaining to the Los Alamitos Municipal Code and the California Vehicle Code; and,

**WHEREAS**, the City Council previously adopted penalties for municipal parking violations within Exhibit "C" (Police Department Fee Schedule) of Resolution No. 1895 approved on October 14, 2002 and Resolution No. 2007-30 approved on September 4, 2007; and

WHEREAS, the City has studied and reviewed the penalties assessed by adjacent cities to assure the penalties are standardized to the extent possible; and,

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOS ALAMITOS  
DOES RESOLVE AS FOLLOWS:**

SECTION 1. The City Council of the City of Los Alamitos, California, finds that the above recitals are true and correct.
