

**MINUTES OF THE CITY COUNCIL
OF THE CITY OF LOS ALAMITOS**

SPECIAL MEETING – MONDAY, July 20, 2009

CALL TO ORDER

The City Council met in Special Session at 4:40 p.m., Monday, July 20, 2009, in the Council Chambers, 3191 Katella Avenue, Mayor Edgar presiding.

RECESS

Mayor Edgar reconvened the meeting at 9:53 p.m. He thanked the remaining applicants in the audience for applying and encouraged them to apply in the future if they were not selected this evening.

Council Member Mejia thanked Dean Hill for applying and encouraged him to reapply for future openings.

Department Secretary Quintanar stated the following indications of support for each applicant to the Parks, Recreation, and Cultural Arts Commission: 5 – Pete Carvajal, 4 – Eileen Doerrer, 1 – Dean Hill, and 5 – Samuel Manning.

Council Member Zarkos stated he had not voted for Eileen Doerrer because he felt she did not have experience outside of the Commission. Mayor Edgar stated he had the same concern and was informed her background was in banking.

Mayor Edgar stated he had voted for Dean Hill and asked Mr. Hill if he was interested in the Parks, Recreation, and Cultural Arts Commission. Mr. Hill declined.

Council Member Mejia thanked Mr. Hill for this exceptional interview and encouraged him to apply in the future. She indicated she had supported the applicants who had applied during the first filing period.
